



## TERMS OF USE

### 1. Agreement between user and Nqpetro

- 1.1 The Nqpetro Web Site is comprised of various Web pages operated by Nqpetro. The Nqpetro Web Site is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein.
